This agreement shall commence as of May 1, 2018. This program agreement shall abide by all language of the Institutional Agreement between Kellogg Community College and Western Michigan University.

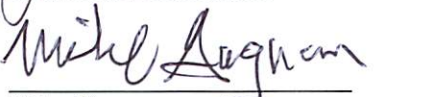

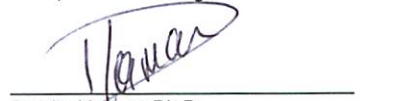
